

## **Volunteer Release and Waiver of Liability Form**

This Release and Waiver of Liability (the "release") releases the Heart of Alabama Food Bank (hereby referred to as HAFB) a nonprofit corporation organized and existing under the laws of the State of Alabama and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for HAFB and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of the Volunteer's relationship with HAFB is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; the HAFB will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury of illness as a result of Volunteer's services to HAFB.

- 1. Waiver and Release: I, release and forever discharge and hold harmless HAFB and its successors and assigns from all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to HAFB. I understand and acknowledge that this Release discharges Heart of Alabama Food Bank from any liability or claim that I may have against HAFB with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to HAFB or occurring while I am providing volunteer services.
- 2. **Insurance:** Further, I understand that Heart of Alabama Food Bank does not assume responsibility for or obligation to provide medical, financial, or other assistance, including medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of HAFB.
- 3. **Medical Treatment**: I hereby release and forever discharge Heart of Alabama Food Bank from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment of other medical services rendered in connection with an emergency during my tenure as a volunteer with HAFB.
- 4. **Assumption of Risk**: I understand that the services I provide to HAFB may include activities that may be hazardous to me including, but not limited to driving, lifting, pushing, pulling, use of cleaning chemicals, etc. Involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release HAFB from all liability.



- 5. **Photographic Release**: I grant and convey to HAFB all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by HAFB in connection with my providing volunteer services to HAFB.
- 6. **Other:** As a volunteer, I expressly agree that the release is intended to be as broad and inclusive as permitted by the laws of the State of Alabama and this release shall be governed by and interpreted in accordance with the laws of the State of Alabama. I agree that if any clause or provision of this release is deemed invalid, the enforceability of the remaining provisions shall not be affected.
